Putz-Technik guarantees for a period of 15 years (from date of completion) that Putz-Technik material components of the coating system, when correctly applied in accordance with our written instructions and detail drawings, will perform and meet the relevant provisions of the New Zealand Building Code Clauses B1 Structure, B2 Durability, E2 External moisture. **On-site application is beyond our control and therefore we do not guarantee workmanship or the correct preparation, installation and application of Putz-Technik components.**

### Conditions of warranty

All the material components of the system must have been prepared and installed in accordance with our written instructions and detail drawings and the work carried out by a Putz-Technik licensed contractor. The paint system applied must comply with Putz-Technik's requirements. The system must have been properly maintained and subjected to no more than normal conditions of exposure. This warranty becomes null and void should the system be cut or damaged whether intentionally or otherwise for whatever purpose without our specific written agreement.

### Limitation of liability

Putz-Technik is not liable under this warranty, or otherwise, for any damage or claim resulting or arising from defective building structure, settling or movements, ingress of moisture or contaminants, excessive wear and tear, hydrostatic pressure, the application of paint with light reflectance value less than 25%, mechanical or physical abuse or any other abnormal cause.

Putz-Technik's liability under this warranty is limited to replacing or at its discretion repairing, or making a contribution to the replacement or repair of, any Putz-Technik material components found to be defective provided written notice is given within the warranty period and within twenty (20) working days of any defect coming to the notice of the building owner. Putz-Technik will not be liable for any incidental or consequential loss resulting or arising from any defect in any Putz-Technik material component used in the system.
