RE:123 LAINGHOLM DRIVE CAR DECK

As requested, a representative from this office visited the above site to inspect a vehicle deck which has been erected without the required Building Consent. In accordance with the brief the scope of this report is restricted to the 7.0m x 5.0m car deck only. No other structures on the property have inspected with the exception of a single post located adjacent to the north eastern end of the car deck.

A site inspection and survey was carried out on the existing car deck. All details, including decking material, joists, bearers and poles were noted. Subsequent structural calculations show that the deck is structurally sound, meeting current code requirements. (see attached calculations for specific details) The handrails skirting the perimeter of the car deck do not meet current code requirements. (ie NZ Building Code and NZS4203).

The car deck is located on a steep to very steep south-sloping bank. No inspections were carried out on the foundations during construction. As such, we are unable to certify the foundations for this structure. However, the builders sketch details have been made available, showing the foundations to be 450mm concrete encased piles drilled to a depth of 2.0m. Calculations assuming conservative bearing strengths, show that the foundations have adequate capacity to support the gravity induced loads. Further detailed geotechnical investigation would be required to confirm the stability of the bank on which the platform has been constructed. This is also outside the scope of this report.

Minor remedial works are required for the pedestrian deck post located adjacent to the northeastern corner of the car platform. (refer to the attached sketch plan for location). Details of the required work are shown of page 5 of the structural calculations.

Our Ref: G184 Page No.

There are signs of soil erosion under and around the car deck. This appears to be a result of uncontrolled stormwater runoff scouring topsoil and fill material. All concentrated stormwater flows should be collected and carried in a sealed pipe system to discharge at a suitable point away from the steep bank located to the south of the vehicle platform.
