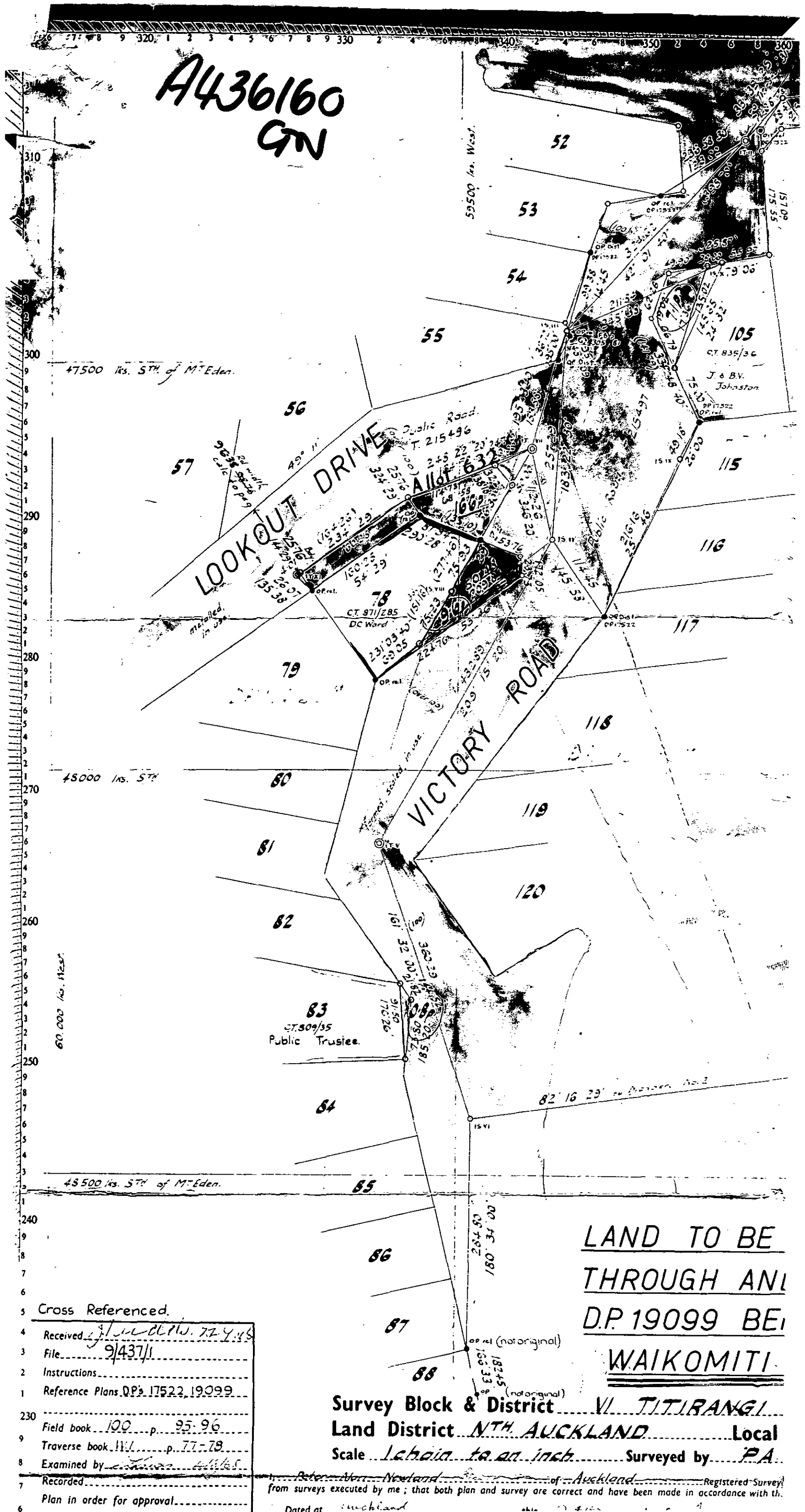

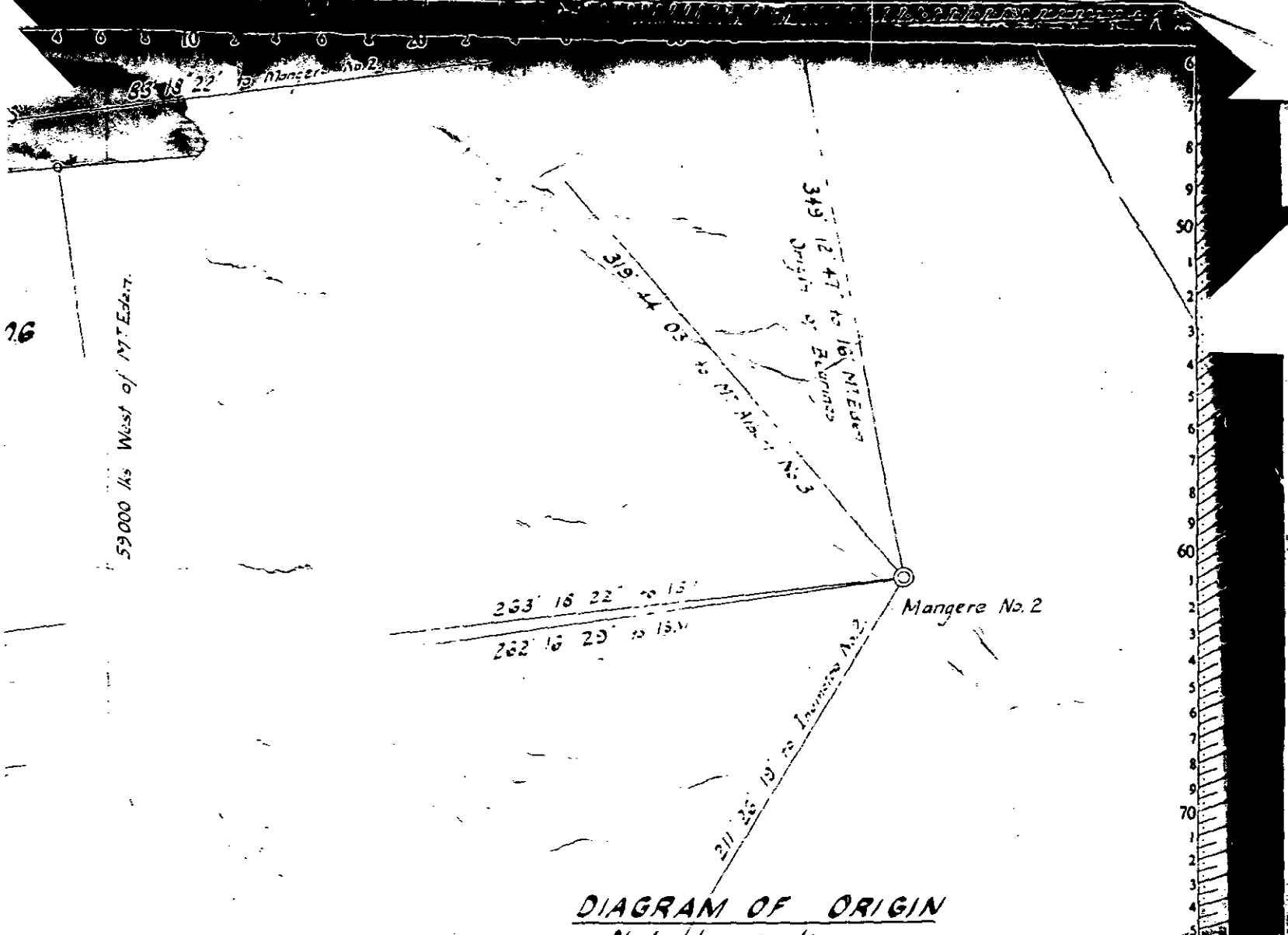


DIAGRAM OF ORIGIN

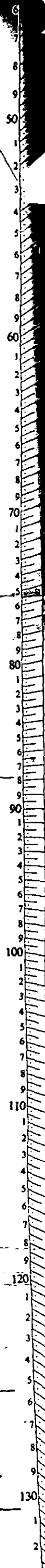

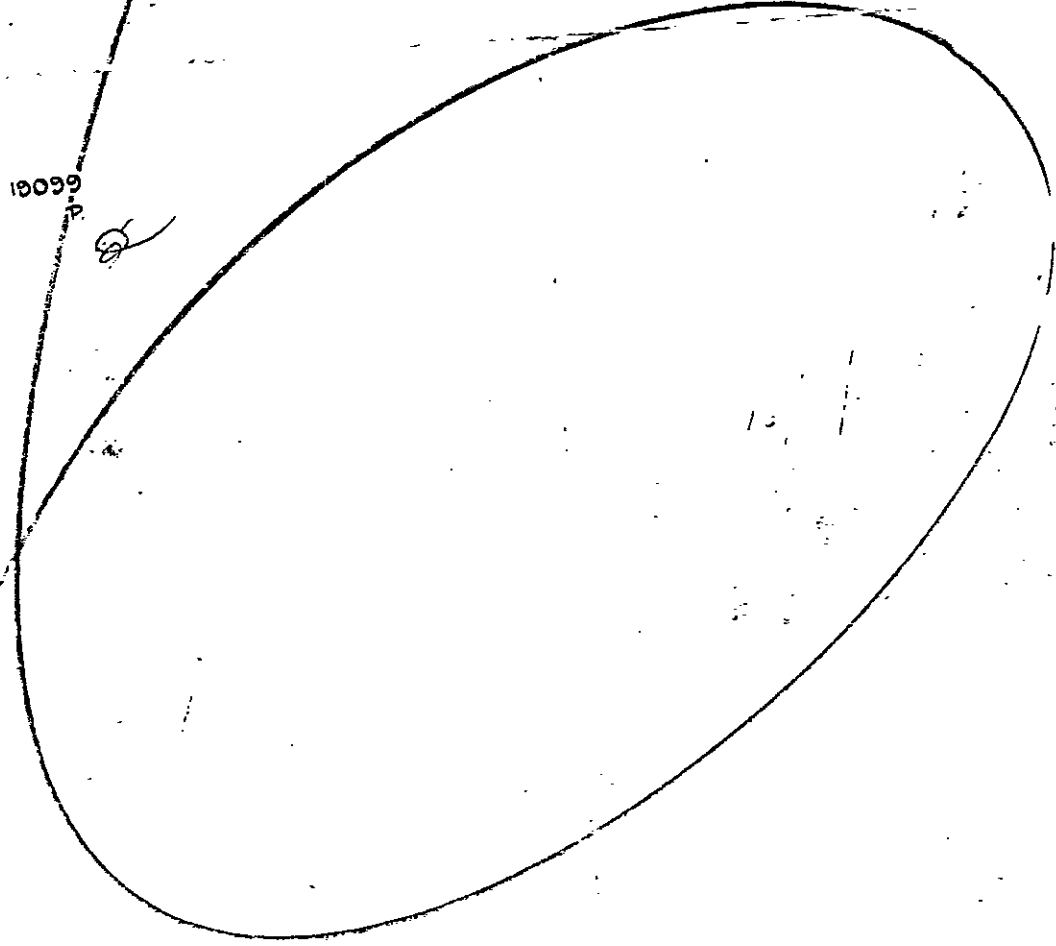
