Pursuant to Section 221 of the Resource Management Act 1991 THE WAITAKERE CITY COUNCIL HEREBY GIVES NOTICE that its subdivision consent given in respect of Land Transfer Plan 205216 is conditional inter alia upon the compliance on a continuing basis by the Subdivider and the subsequent owners of the land in the Second, Third and Fourth Schedules hereto with the condition/s set forth in the First Schedule hereto.

FIRST SCHEDULE

The Owner shall not:-

- 1. Place, erect, construct or permit to remain on any part of the land described in the Second Schedule hereto any buildings unless:-
 - the foundations of such buildings have been the subject of specific geotechnical investigation and design by a registered engineer experienced in geo-mechanics who is familiar with the said Geotechnical Report; and
 - all such construction is carried out in accordance with that design to the satisfaction of the Waitakere City Council.
- 2. Place, erect, construct or permit to remain on any part of the land described in the Third Schedule hereto which is not located within the defined building areas specified in the said Geotechnical Report, any buildings unless:-
 - the foundations of such buildings have been the subject of specific Geotechnical investigation and design by a registered engineer experienced in geo-mechanics who is familiar with the Hugh Fendall Consultants Limited's Geotechnical Report dated 9
 December 1999 (held in Council's records under SPW17331); and
 - all such construction is carried out in accordance with that design to the satisfaction of the Waitakere City Council.

- 3. Place, erect, construct or permit to remain on any part of the land described in the Fourth Schedule hereto located within the defined building area specified in the said Geotechnical Report, any buildings unless:-
 - all construction is carried out in accordance with the requirements of NZS 3604;1998; and
 - further Geotechnical investigation and appropriate design is carried out by a
 registered engineer experienced in geo-mechanics that addresses the issue of good
 ground, especially with respect to expansive soils; and
 - all such construction is carried out in accordance with the above design to the satisfaction of the Waitakere City Council.
